This Agreement is made between **chiangning.net** (the “Licensor”) and the individual or entity acquiring the assets (the “Licensee”). By downloading, copying or using the Assets, the Licensee agrees to the terms below.

## 1 Definitions

“Assets” means the image files comprising the Landscape Entourage Library — the transparent cut-out PNGs and their white-background source PNGs — together with any accompanying documentation.

## 2 Grant of License

The Licensor grants the Licensee a non-exclusive, worldwide, perpetual, royalty-free and non-transferable license to use, reproduce, modify and adapt the Assets, and to incorporate them into the Licensee’s own works, subject to the restrictions in Clause 4.

## 3 Permitted Uses

- Architectural and landscape drawings, elevations, sections, plans and renders.
- Client deliverables, competition entries, planning submissions and printed documents.
- Presentations, portfolios, and marketing of the Licensee’s own projects and services.
- Modification, recolouring, scaling and compositing of the Assets within the above works.
- Both personal and commercial project work, with no limit on the number of projects.

## 4 Restrictions

- The Licensee may not resell, sub-license, share or redistribute the Assets on their own, or in any form whose primary purpose is to convey the Assets to a third party.

- The Licensee may not include the Assets in any stock-image, template or asset library, or any competing product.
- The Licensee may not represent the Assets, in unmodified form, as their own original artwork.
- Incidental inclusion of the Assets as part of a larger, value-added deliverable (e.g. a drawing set issued to a client) is permitted.

## 5 Ownership

The Assets are licensed, not sold. The Licensors retain all right, title and interest in the Assets and the Landscape Entourage Library, except for the limited license expressly granted herein.

## 6 Attribution

Attribution is not required. Where practical, a credit to “chiangning.net” is appreciated.

## 7 Disclaimer of Warranty

The Assets are provided “**AS IS**”, without warranty of any kind, express or implied, including fitness for a particular purpose, botanical or horticultural accuracy, or non-infringement. The Assets are illustrative entourage and are not a substitute for a horticultural or planting specification.

## 8 Limitation of Liability

To the maximum extent permitted by law, the Licensors’ total liability arising out of or related to this Agreement shall not exceed the amount paid by the Licensee for the Assets, and the Licensors shall not be liable for any indirect, incidental or consequential loss.

## 9 Term & Termination

This license is effective until terminated. It terminates automatically if the Licensee breaches any term. On termination the Licensee must cease use of the Assets, save for Assets already embedded in deliverables issued before termination.

## 10 Governing Law

This Agreement is governed by the laws of New South Wales, Australia, without regard to conflict-of-law rules.
